SAND BAGS AVAILABLE

Sand bags are available at the Old Tumbleweed Store (Address: 11985 US-89), just north of the Summit Fire Station #33 on Highway 89. Bring a shovel to make your own or take what you need from the pallets of pre-made sand bags. Instructions for constructing a sand bag wall, including a video, are available on our webpage listed above.

JERSEY BARRIER REQUESTS

Residents may request a jersey barrier assessment via telephone at (928) 679-8393 or email at schultzfloodrecovery@coconino.az.gov. Our team works directly with residents to create the best plan for individual properties.

DEBRIS HAUL-OFF SERVICES

Coconino County will haul-off debris that residents pile along their property line/roadway for pick up. A checklist of requirements for the Debris Haul-off Services is listed on the back of the sheet. Please be sure that you can meet all of the requirements on the check list.

LANDFILL DROP-OFF

All properties within the flood boundaries are invited to drop forest debris directly at the Cinder Lakes Landfill. Show proof of residency to access free services beginning July 25 through August 10 during normal business hours. Flood boundaries include Highway 89 to the east, Copeland Lane to the south, US Forest Service land to the west and Pabst Way to the north.

DEBRIS HAUL-OFF SERVICES RESIDENT CHECKLIST

SCHULTZ COMMUNITY RECOVERY

Coconino County will haul-off debris that residents pile along their property line/ roadway for pick up. In order to qualify for Debris Haul-Off Services, you must complete the following:

- Contact Coconino County to request Debris Haul-Off Services by Friday, August 3. Provide your name, phone number and address to 928-679-8393 or email schultzfloodrecovery@coconino.az.gov.
- Upon clearing your property, pile debris at the edge of your property in an area that is accessible for equipment. The location should not impede traffic, drainages or interfere with roadway construction.
 - Debris must be located 10 feet away from utility boxes and utility poles
 - Debris must be separated into three categories
 - Rocks (larger than 18 inches in diameter)
 - Dirt (including rocks smaller than 18 inches in diameter)
 - Other forest material

IMPORTANT NOTES

- Debris will be hauled-off periodically beginning July 27 through August 10.
- BULK HOUSEHOLD WASTE IS NOT ACCEPTED.
- Hazardous Waste must be taken to the Cinder Lake Landfill.
- Coconino County team members are available to help you identify the best place to locate your debris for haul-off and answer your questions.
