A RESOLUTION OF THE BOARD OF SUPERVISORS OF COCONINO COUNTY, ARIZONA ADOPTING THE COCONINO COUNTY PERSONNEL POLICY MANUAL AS A GUIDE FOR PERSONNEL ADMINISTRATION; AND SUPERSEDING, REPLACING AND REPEALING RESOLUTIONS 1974-31, 1979-15, 1996-10, AND 2003-27; AND REVISIONS ADOPTED ON OCTOBER 7, 1996, MAY 10, 2000, AUGUST 7, 2000, DECEMBER 4, 2000, DECEMBER 16, 2000, DECEMBER 18, 2001, MARCH 11, 2014, SEPTEMBER 1, 2015, NOVEMBER 1, 2016, JUNE 20, 2017, JUNE 27, 2017, NOVEMBER 13, 2018, NOVEMBER 12, 2019 AND JUNE 29, 2020 AND ANY RIGHTS CREATED BY THEM.

WHEREAS, the Coconino County Board of Supervisors under A.R.S. 11-251 has the authority to establish conditions of employment, compensation, and benefits; and

WHEREAS, the Coconino County Board of Supervisors wishes to provide for a uniform system of personnel administration throughout the County service; and

WHEREAS, a uniform Personnel Policy Manual has been drafted to facilitate this goal; and

WHEREAS, the policy Manual has been drafted after opportunities for review and comment have been given; and

WHEREAS, the policy Manual incorporates recommendations and suggestions for change;

NOW THEREFORE BE IT RESOLVED that the Board of Supervisors adopts the attached Coconino County Personnel Policy Manual, subject to the procedures and restrictions set forth within the said policy manual, as a guide to uniform personnel administration within Coconino County. This policy manual supersedes and replaces all other Personnel Policies adopted prior to this date of adoption. A hard copy of the Coconino County Personnel Policy Manual is available at the office of the Clerk of the Board of Supervisors.


