

NAME CHANGE

YOU CAN USE THIS PACKET IF ALL THIS IS TRUE:

- You want to legally change your name and/or the name of your child under age 18.
- Each person whose name you want to change lives in Coconino County.
- You are at least 18.
- If you want to change your child's name:
 - Both parents are at least 18.
 - Either 1) both parents will sign or 2) paternity has not been legally established.

Paternity has been legally established if:

- A court order names Father as the children's father.

OR

- Mother and Father signed an Acknowledgment of Paternity through the hospital paternity program or other means provided by law after July 18, 1996, and a birth certificate listing Father as the father was issued as a result.

Before signing a court document or getting involved with a court case, it's important to see an attorney to make sure you understand your legal rights and responsibilities. The Self-Help Center has information on finding an attorney.

ORDER CHANGING NAME

- FOR AN ADULT**
 FOR A MINOR

The Court Finds: Each person whose name change is requested is a resident of Coconino County. If a name change is requested for a minor, the minor's natural or adopted parents agree to the name change or paternity has not been legally established. Good cause exists to grant the request.

The Court Orders: This order does not end any rights or obligations under the original name. For each birth certificate name change ordered, for Arizona birth certificates, the Department of Vital Records shall issue a new birth certificate with the new name.

For any changes to birth certificates ordered below, for an Arizona birth certificate, the Arizona Office of Vital Records is ordered to amend the birth record to reflect the new name, and, for a birth certificate issued in another state, to the extent that the agency that maintains birth records in that state is authorized to honor an order of this Court, that agency is requested or ordered to amend its birth records to reflect the new name.
