On April 17, 2018, HB 2249, was signed by the Governor, adopting new procedures for processing Orders of Protection.


To promote consistency and implementation of the new procedures for processing of protective orders throughout Coconino County, an Order of Protection workgroup is established.

IT IS ORDERED that the Order of Protection workgroup will review Coconino County's current policies and procedures regarding processing of orders of protection, suggest changes to current policies and procedures based upon HB 2249, recommend improvements in the processing of orders of protection, develop protocols to educate victims seeking orders of protection and develop training for court staff. The workgroup shall provide a report to the Presiding Judge no later than December 1, 2019.

IT IS FURTHER ORDERED that the individuals listed on Appendix A are appointed as members of this workgroup beginning upon entry of this Order and ending on February 28, 2020. The Presiding Judge may appoint additional members as necessary.

IT IS FURTHER ORDERED that workgroup meetings shall be scheduled at the discretion of the Workgroup Chair.
