15 Pursuant to Rule 15.1(i), Arizona Rules of Criminal Procedure, Defendants
16 Elizabeth Archibeque, Anthony Jose Martinez and Ann Marie Martinez and the
17 State hereby agree and stipulate to extend the time for the State to file its Notice of
18 Intent to Seek the Death Penalty for 60 days beyond the 60 day time limit after the
19 defendants' arraignment.


20 All three Defendants were arraigned on March 23, 2020. Rule 15.1(i)(1)(A)
21 requires the State to file the Intent to Seek the Death Penalty no later than 60 days
22 after the arraignment. Sixty days from March 23, 2020 would be May 22, 2020.
23 Rule 15.1(i)(1)(B) allows the Court to extend this deadline for 60 days if the
24 parties file a written stipulation. Sixty days from May 22, 2020 would be July 21,
25 2020. Due to the current travel and visitation restrictions in place because of the
26 coronavirus pandemic, additional time will be needed for all defendants to provide
27 information to the State relevant to the State's determination regarding the

1 possibility of filing the Notice. As such, all parties stipulate to this extension.
