## Fort Tuthill Utility Improvement Project Approved for July Groundbreaking

Dear Mountain Dell Resident:

- ◆ On Tuesday, June 9, 2020 the Board of Supervisors approved the **Fort Tuthill Utility Improvement Project**. Funded by the Coconino Parks and Open Space Sales Tax, this \$2.1 million project includes the installation of 1.5 miles of sewer line and 2,000 linear feet of water infrastructure from University Heights through Mountain Dell to Fort Tuthill in order to provide sewer service to Fort Tuthill County Park.
- ◆ The project's contractor, Overlay's Est. 1959, is expected to break ground on the project during the first full week of July. The project is slated for completion this fall; however, this schedule is subject to change due to weather or other unforeseen factors.
- ◆ The contractor will begin at the north end of the project near University Heights and work southward with the goal of installing 200 feet of sewer line per day. This would put construction in Mountain Dell sometime in early to mid-August when installation of the sewer service connections along Palmer Avenue will take place.
- ◆ The Mountain Dell segment of the Fort Tuthill Utility Improvement Project will be constructed in coordination with the **Mountain Dell Drainage Improvement Project**, which is currently in progress. Drainage project crews have already set sleeves for the upcoming sewer connections.
- ◆ Flagstaff Urban Trail System (FUTS) users should be prepared for trail reroutes beginning in July and ending in October along the Sinclair Wash Segment (west end) leading to Fort Tuthill County Park. Reroutes will be close to the existing FUTS Trail but will bypass the construction work.
