## 2. Supervisor Ryan

- Focus on working together with everyone to solve community issues and focusing ahead on locating a site for a potential equipment barn in the Munds Park community. Have a community-based solution that makes sense for the wider community and our Public Works organization.
- Lucinda Andreani, Deputy County Manager/Public Works Director: We have been working on finding a potential site for an Equipment Barn in Munds Park for many years. We missed an opportunity to engage the community and proactively communicate on the Equipment Barn on



Hillside, but we are looking forward to working together with this Committee. At the next meeting, we want to share information about the services and investments our Public Works provides in the community, including in the Munds Park.

- What is the funding and the need: Develop a Cost-Benefit analysis and find out where the MP Equipment Barn ranks across the list of Projects and Services across the County.
- Articulate the need for the Equipment Barn for both the Committee and the public: Public Safety, School buses, Emergency Responders. Will the equipment stored in the Barn be for Munds Park Community? Primary to serve the MP community, but the County may be responding to broader regional needs when emergencies arise. We will make sure to address this in the Presentation at our next meeting.
